18-19/50 The Minutes of the meeting held on 15 January 2019 were approved as a correct record.

DEFIBRILATORS

18-19/51 Further to previous discussions, the Council agreed to proceed, if possible, to instal a defibrilator adjacent to the school at the agreed price of, £1,526.40 (inc VAT) and subject to the approval of electrical connection to the satisfaction of the school and appropriate training, insurance etc.

FINANCE

18-19/52 (a) The Parish Council approved the following items of expenditure:

Clerk's Salary -2 months @ £120.11 = £240.22 Clerk's expenses - travel - £16.00 (to post notices and to attend meeting). Annual website hosting - A Keppel - £65.

PLANNING

18-19/53 The Council considered the following applications:

19/0218N – Variation of condition 2 to Planning Application 16/3057N – rear first floor extension – Briar Cottage, London Road, Bridgemere – no objections.

19/0681N – Bespoke lean-to extension to replace conservatory – The Old Vicarage, Bridgemere Lane, Hunsterson – no objection. (Councillor Clowes decalred a personal interest in this application and left the meeting diring its consideration.

19/0762N – Change of use of proposed conversion brick outbuilding to new dwelling – Melrose, Mill Lane, Blakenhall.

Lea Hall Barns – no objection, but to express concern about the possible presidencial implications regarding neighbouring properties.

(b) The Council noted the following decisions:

18/6372N - Certificate of Lawful Development for an Existing Use of land as domestic garden, incidental to use of Foxes Bank Cottage as a dwellinghouse (C3) – undecided.

18/5903N – Doddington Hall – Variation of conditions on Listed Building Consent 14/5656N – approved.

18/4995N – 1 and 2 Pewit Hall Cottages – alterations and extensions – approved.

18/5285N – Yew Tree Cottage, London Road, Bridgemere – Construction of replacement dwelling – undecided

19/0338 – Erection of new garage – Greenfields Farm, Greenfields Lane, Hunsterson – approved.

HIGHWAYS
