19-20/20 The Minutes of the meeting held on 15 July as a correct record.

MATTERS ARISING

19-20/21 The clerk reported that Cheshire East Council had declined a request to site visibility mirrors at Four Lanes End – it was noted that property owners at the junction had cut back hedges

DODDINGTON HALL

19-20/22 Councillor Clowes explained the process regarding the ongoing appeal.

Responses had been collated on behalf of the Parish Councils affected and a request been made for sight of the financial documents which the appellant was required to put to the inspector.

The responses included financial concerns, flawed consultation, viability of the hotel, community concerns regarding reserved matters, infrastructure, and planning policy regarding enabling development.

The Parish Council recorded its thanks to Councillors Clowes and Frodsham for their work in putting together the responses.
