MINUTES OF THE MEETING HELD 18 NOVEMBER 2019

19-20/33 The Minutes of the meeting held on 18 November as a correct record.

SUSPENSION OF STANDING ORDERS

19-20/34 The Parish Council resolved to suspend Standing Orders to allow the first part of the meeting to enable members of the public to contribute to discussion on the next item on the agenda.

DODDINGTON HALL

19-20/35 Councillor Clowes reported on the public inquiry was due to be held from 11 February 2020 at Wychwood Park Hotel. The procedure was explained and members of the public made observations on the procedure and issues and asked questions.

Andrew Thompson attending assisted in answering questions and setting out the issues.

Having resolved to reconvene the meeting of the Council, it was agreed that Councillor Clowes put together action points and to act as a point of contact having, hopefully, to meet with Cheshire East Council's legal representatives.

AIRMEN'S MEMORIAL - PRINCE'S HILL

19-20/36 Further to Minute 29 Councillor Rogers reported that he had been in contact with Nantwich Air Cadets and would report back to the next meeting on ideas for the future organisation of memorial services at the Memorial.

FLOODING ISSUES

19-20/37 Further to Minute 30 the Council considered the ongoing flooding issues in the area, in particular in Mill Lane, Blakenhall, Checkley Lane, Checkley and Dingle Lane, Bridgemere.

It was noted that in regard to Mill Lane, Cheshire East Highways had prepared a schedule of works to be undertaken once the flooding had drained away including clearing drains and capacity tanks which had been identified by former Councillor David Lane.

It was noted that the flooding had identified a silted-up brook near the railway bridge in Checkley Lane which had contributed to the flooding issues.

In Dingle Lane it was noted that extensive damage had been caused to the bridge and ford and for which the Doddington Estate had accepted responsibility.

FINANCE

19-20/38 (a) Budget 2020-21

Having resolved that Councillors currently in office had a dispensation to discuss financial matters relating to the budget and setting of the precept, and after considering a budget prepared by the Clerk (amended and appended to these minutes), the Council agreed to precept Cheshire East Council in the sum of £3,047.

(b The Council approved the following items of expenditure:

Clerk's Salary -2 months @ £123.75 = £247.50 Clerk's expenses - travel -£24.00 (to post notices and to attend meeting) - printer toner - £16. Website hosting- £42.00

(c) The Clerk reported that on current balances which stood at £10,566.26 (current) and £252.70 (deposit) at 30 December 2019.

CHESHIRE EAST COMMUNITY GOVERNANCE REVIEW

19-20/39 The Clerk reported that Cheshire East Council had commenced a review of governance arrangements in the area.

In brief CEC was looking for comments on the boundaries of parishes, particularly where developments may have occurred across old local boundaries and on the arrangements for governance such as the creation of combined councils.

It was agreed that at this stage the Council would report that it had no desire to change arrangements in the district.
